
Objectives of the research

The adaptability of a building organism is usually more evident in the design of its envelope as it is the to environmental stresses and even trigger regenerative processes. They are among the most topical technological subjects in biomimetic architectural research. Thanks to new active functions, building envelope can optimize worldwide which, in order to achieve dynamic adaptation, exploit mechanical actuators (Fig. 1), the responsiveness of materials (Fig. 2) or the integration between technology and biology (Fig. 3). The research aims to draw a scientific framework to investigate how to reduce complexity and structural ragility of adaptive technological systems, improve their control capabilities, minimize energy expenditure for actuation and even generate power or enable positive ecological processes.
